**Legal Hotline Service** – One of the greatest benefits that MARE member school districts receive is the opportunity to participate in the Legal Hotline Consultation Service. This service allows for unlimited telephone consultations with a school attorney to get answers to minor legal issues. The following terms pertain to this MARE member service:

- Annual MARE membership must be current.
- **The district staff making the call must inform the attorney that this is a MARE member school district phone call.**
- The service provided must be of an advisory nature.
- The service does not include the following:
  - 1) In-depth research
  - 2) Preparation of documents
  - 3) Review of documents mailed or faxed to the firm
  - 4) Written opinions
  - 5) Any consultation in conjunction with the firm's current representation of the district.
