Missouri School Directory 2016-2017:

As was indicated in the annual membership renewal, MARE is making a copy of the Missouri School Directory (last one published 2010-2011) available to each MARE <u>member</u> school district and associate member. These will be mailed out next week to district Supt.'s, that <u>did not</u> pick theirs up at a regional meeting or at the conference.

"RYH4K" (Amendment 3)

The MARE Executive Board is one of several organizations in Missouri that are opposed to the passage of the initiative – "Raise Your Hands for Kids." The MARE organization very much supports the need for Early Childhood Education but has some serious concerns about some of the language found within this ballot issue and the effect its passage would have on rural school districts in Missouri.

"RYH4K allows the new tobacco tax funds to be sent to private or parochial schools. This is accomplished by using language which states that, "*Distributions of funds under this amendment shall not be limited or prohibited by the provisions of Article IX, section 8,*" This language is specifically designed to circumvent the Blaine Amendment, which is part of the Missouri state constitution. It's About Big Tobacco's Profits, Not Kids. It seems unusual that Big Tobacco would support a tobacco tax increase. It makes more sense, however, when it is understood that Amendment 3 ALSO includes language to help major tobacco brands drive up the price of their low-cost competitors.

The extremely flawed Amendment 3 also creates a non-elected commission (no one from education associations) to manage and fund the Early Childhood Program with very little accountability. This creates a dangerous precedent for Missouri. Non-elected commissioners are not accountable to the voters and taxpayers of Missouri and may seek to promote their own private agendas.

RYH4K doesn't want voters to read the full measure. I encourage voters to do so.

Funding for early childhood education is very important, but should not be driven by Big Tobacco and other political interests. Remember both candidates for Governor as well as over 100 legislators have come out opposed to Amendment 3.
