# **Open Enrollment – The Momentum of Opposition is Growing!**

As many of you are aware, the open enrollment bills (HB 253 and SB 5) are quickly making their way through the legislative process in both the House and Senate. Each bill received a hearing this past week and are expected to be voted on in their respective committees this week. We expect them to be on the floor very soon.

I *strongly* encourage everyone to view this <u>video recap</u> of the committee hearing on HB 253 that was put together by our friends at the Missouri State Teachers Association. As you can see, the fear of consolidation of our schools is very real.

The outcome of these bills is far from certain.

For the past two years, the open enrollment bill has narrowly passed the Missouri House. Given the outcome of the most recent elections, several lawmakers that voted in favor of previous bills are no longer serving in the Missouri House and have been replaced by lawmakers that may take a different position.

Every day, we are hearing more and more districts are adopting resolutions opposing open enrollment. Currently, we are aware of 90 districts that have taken this action. If you have not yet taken this action, to keep our momentum moving forward, I would ask you to consider that action in your upcoming board meetings. I have attached a draft resolution for your consideration.

Additionally, the opposition to this bill is growing as stakeholders and communities understand the true impact on public education. Just this past week, we received word that the Jefferson City News Tribune has taken a position against open enrollment.

As a result of what we are seeing in some communities, if you have already passed a resolution opposing open enrollment or if you take that action in the coming weeks, please make sure you are sharing information about that action with your local media. The best way for us to be effective is to ensure that the public is paying attention to the true impact this policy and are weighing in on their opinion the policy will have on students, schools, and communities.

Additional talking points to consider:

- 1. There are Two Sides to Open Enrollment: Proponents like to point to the benefits that open enrollment provides to the students who transfer. And while there may be a benefit to the students that take advantage of this option, there are additional students policymakers need to keep in mind: the students who remain in the resident district. A student leaving their district of residence, means those state resources leave as well, and the students who remain have fewer resources available for their educational experience.
- 1. Reasons Why Kids Might Transfer: Proponents of open enrollment like to point to the creation of competition in education to improve outcomes. While that may be true, it assumes that parents if given the option will decide based on the quality of their resident district. It is likely that convenience may be the most likely factor in a parent's decision to send a student to another district. For example, if the parent works in a neighboring district, it might make more sense to enroll your child in that district. As a result, resources that would have come to your district are sent to the neighboring district and the students that remain in your high performing district are left with less.
- Loss of Community Support: If parents are allowed to send their students to another
  district in which they do not pay property taxes, school districts should expect for less
  community support and involvement. If individuals are living within their resident district but sending their children to a nonresident district, those individuals will be less likely to support ballot measures to increase their taxes in the resident district.
- School Consolidation: Open enrollment will lead to school consolidation. Many associate school consolidation with smaller schools. However, school consolidation is not limited to just small, rural districts. Urban/suburban districts that are also financially fragile will have significant difficulties with the passage of this bill and it may result in their consolidation as well.
- 1. <u>Elimination of Programs:</u> If students leave a district, it will very likely be spread across multiple age groups and grade levels, meaning a district will not always be able to eliminate staff. This means that a district will instead be forced to look at cutting programs meaning the students that remain in the district could see fewer opportunities in their resident district. (e.g., loss of programs such as choir, band, scholar/debate teams, FFA, DECA, and athletic programs).
- 1. Voluntary Participation?: Advocates for open enrollment have stated that the bill is "voluntary" in that no district is required to accept open enrollment students. While true, districts should be aware that the bill does not prohibit students from leaving a school district if another public school is accepting students. Thus, even if District A decides not to participate in the open enrollment program, students from District A can still leave to attend a public school in District B that is accepting open enrollment students. Further, if this policy passes, our membership should expect for school ref orm advocates to remove the voluntary status in the future, thus, requiring districts to participate.
- Diverting Resources for Marketing & Advertising: Unfortunately, open enrollment will pit public schools against one another. School districts will compete for students and large sums of money that should be uti-

lized for the education of children will instead be used for marketing and other recruitme nt materi-

als. Schools will also be forced to "one up" one another for the best facilities and best sports programs which will further deplete money going into the classroom.

Financial Planning Nightmare: Open enrollment will create further uncertainty in school districts. School districts will likely be forced to hold larger sums of money in reserve in case

swings in student population occur. This may result in teacher salaries remaining stagnan t or place valuable educational programs on hold.

1. <u>Special Education</u>: The current bills permit districts to deny students based on special education sta-

tus if the district determines that they cannot meet the special education student's needs . While this may be something a district that participating in the open enrollment program may seek, it puts districts in a challenging position to take that action against a special education student. This approach is also fraught with possible legal problems down the road as federal special education laws change and courts make decisions on the litigation that is common within special education policy.

1. <u>Transportation Concerns:</u> The current versions of open enroll-

ment create inequities for students regarding transporta-

tion. Transferring students (except for those students who qualify for free and reduced lunch as discussed below) or

their parents, are responsible for the transportation of

the student. However, the parents and the nonresident district may enter into an agreem ent that allows the parents to transport the student to an existing bus stop if there is capacity available on

the bus. Students who qualify for a free and reduced lunch and transfer to a bordering district

school shall have transportation costs reimbursed by the Parent Public School Choice Fund. This ap-

proach fails to consider those families that lack any form of transportation (especially in rural areas where no public transportation exists). It also fails to consider the homeless student popula-

tion. As such, these students will lack the ability to participate in open enrollment further creating "haves" and "have nots."
