Calculate & Communicate — Districts are encouraged to calculate how much of the grant money for the state minimum salary (\$38,000.00) they are drawing down and to communicate with your legislators what might happen should that grant program be phased out accompanied by a mandatory minimum teacher salary of \$38,000.00 or higher. It is important for your elected officials to understand what impact this would have on your district including possible program cuts, staffing reductions, delaying of facility improvements, unrealistic local tax levy burdens, etc. Now is the time to begin to prepare this information and have these conversations so that your legislators are informed and hopefully will look for ways to continue to fund an improved minimum teacher salary in our state.

What is Bond Insurance and How Can it Help You?

What is Bond Insurance?

Bond insurance is a type of insurance policy that a bond issuer purchases that guarantees the repayment of the principal and all associated interest payments to the bondholders in the event of default. Bond issuers will buy this type of insurance to enhance the credit rating on a bond issue, which makes the bonds more attractive to potential investors and reduces the amount of interest that needs to be paid. From the issuer's perspective, if the cost of the insurance policy is less than the interest savings, then using bond insurance to lower the overall borrowing cost is worth considering.

How Can Bond Insurance Help You?

Bond insurance can be an effective tool to raise the rating on a bond issue and reduce the amount of interest paid. Bond insurance is generally useful for issuers of bonds that have an underlying bond rating in the "A" category or lower. When evaluating the benefits of bond insurance, it is important to closely evaluate any conditions or requirements included in the insurance commitment as bond insurance companies may impose requirements such as a debt service reserve fund, parity debt covenants and collateral requirements.

Your underwriter should take the time to analyze the benefits of bond insurance as it can make a substantial difference in the amount of available funds in the Project Fund. This analysis includes comparing the cost of the bond insurance premium to the interest savings derived from the lower insured bond yields versus the expected bond yields to be received on an uninsured basis. For example, the interest rates and yields for a "AA" rated, insured bond issue would be lower than a bond issue that is not insured and is being sold with an underlying bond rating of "A".

In April 2023, Raymond James served as Underwriter for the issuance of \$25,610,000 Lease Certificates of Participation for Savannah R-III School District. To minimize interest cost and maximize the available funds for the project, we took the time to solicit bond insurance quotes. Our efforts to obtain quotes from both Assured Guaranty and Build America Mutual ultimately resulted in a favorable quote. Overall, the District received an insured rating of "AA" and achieved net savings (total savings less cost of bond insurance) of roughly \$776,555.

Anonymous Thoughts on Open Enrollment

Merely Hypothetical at This Juncture

Open Enrollment is currently being considered by the Missouri legislature. As with any new initiative, the many facets of the change are being debated. There is talk of timelines, enrollment capacity, lottery systems, voluntary vs. mandatory participation, finance, transportation, etc.

In an effort to suggest how Open Enrollment legislation might affect students, parents, schools or communities, a group of hypothetical individuals were interviewed. These folks could be called the "boots on the ground" as they will be on the front lines of this legislation.

- Catching the school bus by 6:30am is pretty early but next year with Open Enrollment I'd have to catch it much earlier to get to my new school. I'm pretty fast so I thought I'd be able to get on the track team. But I just found out, there's no bus for transfer students. With no reliable vehicle, if I get accepted, they'll just kick me out for truancy. Being poor makes it hard to take advantage of good stuff. (Interview Scott 9th grade)
- All these school commercials confuse me. My mom says when she was a kid they had magnet schools. (Interview Joaquin 7th grade)
- I thought my teaching job was tough enough but trying to communicate with parents now that they live further away, is really a challenge. I used to know most of the families in our small community. (Interview Ms. Jones 5th grade teacher)
- My daughter, Amy, was very excited to be able to attend our neighboring school where she can take Band. She is very talented and has loved music for a long time. But she does not like their math teacher and they only have one section of math. I'm wondering if we could work it out so she attends Band at one school and math at another. Surely, she can do Open Enrollment part-time. (Interview Amy's mom)
- I was so proud when I was elected to our Board of Education. Local control is a tradition in public education. Now I've heard that there is talk that Open Enrollment has an Appeals process to the State Board. How will that impact our local decisions? (Interview BOE member)
- Every couple of years a coach gets a really special player. I've been mentoring him through Middle School and I'm not the only one that's noticed his progress. The community has seen him grow up and has been looking forward to great things from our "hometown" boy. But these twins that transferred in are tougher, more aggressive players and are taking over the court. Parents and other community members are on my case. (Interview basketball coach)
- I've worked hard all four years of High School. This new kid just transfers in and is now number one in our class. Were her teachers and classes as hard as mine? (Interview with aspiring valedictorian)

This is just a small sample of the hypothetical interviews that were conducted. While some individuals are looking forward with anticipation to the opportunities of Open Enrollment, others take a more thoughtful, long-term view. They remember that these are the same students that survived education during COVID and Open Enrollment may further disrupt their educational opportunities. (Anonymous)
