Missouri will use \$55 million from the state's Coronavirus Relief Fund to expand educational opportunities for students and address two key challenges the COVID-19 pandemic has presented for K-12 education: student internet connectivity and potential learning loss during extended school closures.

While school buildings were closed this spring, one in five Missouri students could not access online learning opportunities due to Wi-Fi availability and/or affordability. On July 2, the Department of Economic Development announced it had allocated \$10 million of the state's Coronavirus Relief Fund to the Department of Elementary and Secondary Education (DESE) to reimburse schools for costs associated with increasing student connectivity and expanding campus Wi-Fi networks for the coming school year. It is estimated that these funds will allow 250,000 new concurrent connections to the internet for students.

DESE will then use nearly \$20 million allocated to the agency through the Governor's Emergency Education Relief Fund and the Elementary and Secondary Schools Education Relief Fund state reserve to support schools in providing additional student devices. Applications and the necessary documentation schools will be required to submit to collect this reimbursement will be forthcoming.

DESE will receive an additional \$10 million of the state's Coronavirus Relief Fund to create a formative assessment tool to gauge the level of learning loss – or growth – students experienced this spring. These funds will also be used to develop strategies to accelerate learning to help students who may have fallen behind get back on track quickly. These short, turnkey assessments will not be used for accountability, but rather as a valuable tool educators can use when students return to school in August to inform instruction and assemble the supports a student may need, with results returned to schools in just one week.

The state is also allocating \$7.5 million of the Coronavirus Relief Fund to reimburse schools for

transportation expenses incurred when delivering meals to students during school closures. Missouri families counted on this assistance, with schools serving over 19 million meals through the pandemic.

An additional \$7.5 million of the state's Coronavirus Relief Fund has been allocated to help schools cover the costs of personal protective equipment and cleaning and medical supplies for schools and buses, as part of a cost-share program with local counties. Just over \$795,000 has also been allocated to reimburse those schools that provided childcare for emergency workers during school closures.

#### **Network for Educator Effectiveness Information**

Based on the experience of last spring, the NEE staff members have worked hard the past three months to prepare materials and resources to help our NEE districts (and any others seeking assistance) with the difficult task of properly evaluating teaching in remote learning settings. The primary focus of these evaluating remote teaching resources follow the same NEE value of helping teachers grow through a supportive evaluation process. Our intent with these materials and training is to get in front of potential issues by providing sound protocols, associated resources, and supplemental training to all involved to reduce the anxiety that will probably come this fall as schools enter another period of likely-changing learning environment.

If you would like to join one of those sessions you are more than welcome to register.

We also plan to schedule a series of online supplemental trainings in August-October to give district staff a more in-depth training in the new materials and protocols as their districts adjust their learning environment and need assistance in effectively evaluating in remote learning settings. We aren't forcing this process or materials on any district---just making it available to their staff as needed. Quite frankly there isn't much out there on this topic to help districts as they maneuver through these uncharted times.

#### **2020 Health Office Orientation** - 2020 Health Office Orientation Updated

Missouri Association of Rural Education (MARE) is partnering with the Department of Health and Senior Services (DHSS) School Health Program and the Missouri Association of School Nurses (MASN) to offer an orientation for health office staff.

Date and Location: The unusual circumstances presented by the COVID-19 pandemic event has caused us to re-think and adjust the plan for the annual program. This year, the Health Office Orientation will be offered as a *virtual* training and orientation package. Learning modules will be posted and the link to accessing the required modules will be shared upon registration. An online live event will be held to allow participants to come together and share their challenges and concerns, and talk with our faculty in follow up to the learning modules, asking questions and clarifying how to apply the materials to their school nursing practice.

**Purpose:** This virtual workshop provides a series of online modules to assist in orienting nurses without prior work experience in schools and an overview of information regarding school nursing practice.

Areas to be addressed include: general school nurse responsibilities, immunizations, communicable diseases, documentation, chronic disease management, medication administration training and

screenings- vision, hearing, dental; as well as review of practices in Special Education Services; Family Educational Rights and Privacy Act (FERPA), and child abuse reporting.

**Who should attend**: Registered Nurses and Licensed Practical Nurses who have not previously worked in schools, and new heath office staff in schools, working without the benefit of a LPN or RN supervisor.
