The Conference Planner at a Glance should be available by mid-August. We are planning a number of new sessions at this year's event, including Board Secretary Training, Board Leadership Training, Core Data Training, District Bookkeeper Training as well as others. Please make plans now to join us!

Open Enrollment – Thanks to our amazing team of lobbyists, led by Mike Lodewegen and Scott Kimble, Open Enrollment did not pass the Missouri Legislature this year. While this is great news and cause for celebration for all public-school districts, you can rest assured that this issue will re-surface as soon as the legislators return to the Capitol. In fact, it will return most likely with a vengeance and be pushed even harder as the 2024 session progresses. We had 184 districts stand up and take action by passing a Resolution in Opposition to Open Enrollment this year. We believe that this information was helpful to our team at the Capitol. We also believe that legislators will want this information as they consider the issue for next session. I am asking that you lead the charge in your district and ask your BOE to consider the attached resolution along with the

accompanying documents below. More information will be shared throughout the summer on how Open Enrollment will impact your district regarding Special Education, Transportation, Tracking/Recording, etc. Please consider taking this action during the summer months, as typically there are fewer items on the BOE meeting agenda and time can be dedicated to this discussion. If you pass the resolution, please scan and email me or Paul Ziegler, Kenny Southwick or Pam Hedgpeth this information for our records. Also, please be prepared to send a copy to all of your legislators when the session kicks off! Working together we can defeat this issue in our great state!

# American Heart Association Information & Opportunity

The American Heart Association is actively working to secure additional host sites for their great work. Please read on below and access the linked articles at the bottom of the article for additional information. Share with anyone in your circle who might be interested.

Now we're looking at Year 2 starting in September and are wanting to identify some additional host sites in Missouri and I wanted to see if groups or organizations came to mind for you that would be ideal for this. The attached FAQ has more details, but in brief:

- HeartCorps sites must be a non-profit or government entity that needs to be able to:
  - o Help with Member recruitment in their local area.
  - Provide a physical workspace, a day-today supervisor, and an opportunity for 40 hrs of service/wk, directly and/or with partners.
- AHA's funding covers the costs of the Member so there is no direct financial cost for host sites.
- Per AmeriCorps regulations, Members are not able to replace/displace current staff (or volunteer positions) but are designed to expand capacity in addressing high blood pressure, nutrition, tobacco, cardiac readiness, and more.
- Sites in the smallest communities have faced challenges in recruitment so, as a matter of
  practicality, sites (while still rural) would ideally have populations of at least 10,000 to draw
  from and/or be close to colleges/universities.
- In exchange for their 1700 hrs of service, Members receive the equivalent of a \$15/hr living allowance, a \$6800 educational stipend, access to insurance and fantastic opportunities for professional development.

Around the country sites have included local public health, hospitals/clinics, community action agencies, libraries, Boys and Girls Clubs, YMCAs, Salvation Army's and more. It could theoretically include school districts if they were particularly focused on health.
