**Superintendent Search Program** – For the third consecutive year, MARE has completed more Superintendent Searches for Missouri public schools than any other agency that provides such in the state. We are proud of this fact and committed to providing a quality, yet affordable search process for your school district. If you plan to retire or leave your district next year, we would be honored to assist in finding your replacement. We appreciate all of those who have given us this opportunity in the past!

**Open Enrollment** – Thanks to our amazing team of lobbyists, led by Mike Lodewegen and Scott Kimble, Open Enrollment did not pass the Missouri Legislature this year. While this is great news and cause for celebration for all public-school districts, you can rest assured that this issue will re-surface as soon as the legislators return to the Capitol. In fact, it will return most likely with a vengeance and be pushed even harder as the 2024 session progresses. We had 184 districts stand up and take action by passing a Resolution in Opposition to Open Enrollment this year. We believe that this information was helpful to our team at the Capitol. We also believe that legislators will want this information as they consider the issue for next session. I am asking that you lead the charge in your district and ask your BOE to consider the attached resolution along with the accompanying documents below. More information will be shared throughout the summer on how Open Enrollment will impact your district regarding Special Education, Transportation, Tracking/Recording, etc. Please consider taking this action during the summer months, as typically there are fewer items on the BOE meeting agenda and time can be dedicated to this discussion. If you pass the resolution, please scan and email me or Paul Ziegler, Kenny Southwick or Pam Hedgpeth this information for our records. ## Why Should My District Consider Joining MARE

On occasion, I am asked by Superintendents, Board Secretaries or Board Members, "Why should our district join MARE?" Although I am always surprised by this question, I believe that there are a number of valid reasons for districts to join. Below is a brief listing of some of the major reasons:

## Not On Tobacco – Youth Cessation Facilitator Training

I am sharing this opportunity in case this is something in which your members may be interested. The American Lung Association in Missouri has a number of scholarships available for their Not On Tobacco (N-O-T) Youth Cessation Facilitator Training that need to be used by this fall. Adults who plan to implement the N-O-T youth cessation program in the next year should complete the training.

N-O-T is an evidence-based youth cessation program designed to help youth ages 14-19 quit or reduce their tobacco or nicotine use, including e-cigarettes. N-O-T is taught by a trained and certified adult in ten, 50-minute sessions. It is most effective in a small group format (6-10 participants) that emphasizes teamwork. The easy-to-use method helps teens quit by addressing total health in order to develop and maintain positive behaviors.

I have included instructions for redeeming the access code below. Once the course is completed, facilitators should send a copy of their certificates to Rachel Sanford (<a href="Rachel-Sanford@lung.org">Rachel-Sanford@lung.org</a>) as proof of participation. Upon successful completion of the facilitator training, participants will receive 3-year certification and access to N-O-T resources.
