2019 Missouri Post-Secondary Success Conference Opportunity

Social-emotional learning (SEL) is critical to students' long- term success. SEL interventions increased students' academic performance by 11 percentile points compared to students who did not participate in SEL programs. The **Missouri Department of Secondary and Elementary Schools** (**DESE**) has recognized the need for schools to support students in developing intrapersonal and interpersonal skills such as Self-Regulation, Self-Efficacy, and Assertiveness through a partnership with the University of Kansas known as the **Missouri Post-Secondary Success project (MOPSS)**. MOPSS is aimed at helping teachers develop strategies and curriculum that systematically promotes SEL across different contexts. **Through this partnership, schools join a two-year cohort that includes free training in either Self-Regulation or Self-Efficacy. Schools also receive free onsite coaching and support during the process. Missouri elementary, middle, and high schools are invited to participate. Apply at:**

is a social-emotional curriculum that addresses the <u>components for effective SELL programs</u> as outlined by Collaborative for Academic, Social, and Emotional, Learning (CASEL).



News from Associate Member, Claim Care, Inc.

Claim Care recently attended a regional training hosted by the MO HealthNet Division (MHD) along with Fairbanks LLC. Attendees received clarification regarding the additional MO HealthNet Direct Services Cost Settlement program. All districts currently participating in the Direct Therapy Program billing fee-for-service claims **must** participate in the Direct Settlement program. Department of Social Services (DSS), MO HealthNet Division (MHD) is to release official written notice regarding this clarification.

Claim Care is working with DSS/MHD to establish an approved Direct Services Cost Based Methodology. Once official notice is released from DSS/MHD regarding the program participation requirement and a Direct Services Cost Based Methodology approved, Claim Care will contact your district regarding the submission of the cooperative agreement and methodology.

If your district is not currently participating in the School District Administrative Claiming (SDAC) Program, please contact Claim Care regarding how these program changes impact program participation.
