### **Energy Loan Program History**

Since 1989:

- 622 loans totaling over \$118 million
- Cumulative savings of more than \$214 million
- Zero defaults



#### Purpose

- Help fund energy efficiency improvements for:
  - Schools (K-12, colleges and universities public & private not-for-profit)
  - Hospitals (public & private not-for-profit)
  - Local governments

(eligible sectors may differ each cycle)

- Help finance upgrades on new construction encouraging energy efficiency design
- Help finance renewable energy projects



### **Project Examples**

- Lighting
- HVAC
- Boiler Upgrades
- Chiller Upgrades
- Renewable Energy Projects
- Process Equipment
- Insulation Upgrades
- Compressed Natural Gas Fleet
- Combined Heat and Power



#### **Benefits**

- Free up your budget for other capital improvements
- ELP loans compare favorably to bonds or commercial loans
- ELP loans are <u>repaid from the savings</u> generated by the energy-efficiency projects
- After ELP loan is paid in full, those energy savings are yours to utilize
- Job creation

Energy savings repay the loan.



### **Application**

- Application process is user friendly
- Auto-calculating worksheets
- Energy audit calculations and reports



### Typical Loan Cycle Timeline

#### Activities

Application cycle open for 120 days.

Loan applications will be approved or disapproved by 90 days from close of cycle.

Loan awards formally announced. After loan agreement has been fully executed, recipients may submit reimbursement requests.\*

\* Reimbursement request process requires approximately 14-30 days. Invoices dated on/after first day of cycle are reimbursable.



### **Reimbursement and Loan Repayment**

- Once the project is complete, recipients submit their Reimbursement Request, Final Project Cost Report, invoices, and canceled checks to the department for review and reimbursement
- The first payment is typically due 120 days from the date of reimbursement and loan recipients repay the department in semi-annual payments
- Loans are repaid from the savings that are generated by the energy-efficiency projects



#### **Recent Results**

• <u>FY2020</u>

13 loans awarded – over \$5.8 million \$777,737 estimated annual savings

• <u>FY2018</u>

22 loans awarded – over \$13 million\$1.8 million estimated annual savings



#### Harrisonville Wastewater Treatment Plant

- Loan Award: \$380,000
- **Project:** Lights, pumps, blower
- Est. Annual Savings: \$42,800
- Loan Repayment: 10 years







### **Ozarks Medical Center**

- Loan Award: \$2,340,000
- **Project:** Hot water boiler improvement, chiller replacement, steam boiler replacement, lighting upgrades, domestic hot water upgrades
- Est. Annual Savings: \$267,700
- Loan Repayment: 10 years









### **Orrick R-XI School District**

- Emergency Loan
- Loan Amount: \$358,250
- **Project:** HVAC System
- Est. Annual Savings: \$39,691
- Loan Repayment: 10 years










#### Missouri Division of Energy Energy Loan Program Fiscal Years 2018 to 2020
